Dear Parents/Guardians and Campers,

Welcome to YMCA Camp Ingersoll's Mega Adventure Program. The Mega Adventure is designed for the young outdoor enthusiast. This summer's activities will be led by Patti Allison and David Brown. Patti is a veteran member of YMCA Camp Ingersoll and is excited to start her first year in Mega Adventure. David has just graduated from Springfield College with a degree in Physical Education. He is a returning Mega-Adventurer and ready for a new summer. Both Patti and David are excited for new adventures and challenges in the upcoming summer!

Young Adventurers will have opportunities to hike, build shelters, go canoeing, and even participate in some fishing. There will be two field trips scheduled throughout the session.

- During the first Thursday Mega Adventure will travel to Avon to canoe part of the Farmington River with Huck Finn Adventures. When campers return to camp they will have the option of staying at camp for an extended day until 6:00pm (when family night starts) or going home on the bus.
- During the second Thursday Mega Adventure will travel with Fishing Camp to Devils Hopyard State Park sessions 1 and 3, or Day Pond sessions 2 and 4 to fish and hike.

We believe in "challenge by choice", which means that no one will be forced into an activity, each adventurer will choose his/her own level of involvement that they are comfortable with. **All campers will be expected to remain involved with the group, giving each other support and accomplishing goals together.** Adventurers will be expected to behave responsibly and respectfully. If at anytime, we feel that a camper is not acting responsibly or is endangering themselves or others, we will not hesitate to remove that camper from the activity and possibly the program.
